申請理由

1. 申請地點位於新界元朗廈村丈量約份第 128 約地段第 137 號(部份)的土地，面積約 510 平方米，由胡勝業(WU SING YIP)先生提出申請，作為期三年的臨時露天存放建築材料用途。
2. 此申請地點位於廈村邊緣分區計劃大綱核准圖編號(S/YL-HTF/12)的「住宅(丁類)」("R (D)")地帶內。申請發展屬「露天貯物及港口後勤用途」，不屬於「住宅(丁類)」("R (D)")地帶內第一欄或第二欄的准許用途。須按條例 16 向城市規劃委員會提交申請，城委會視乎情況考慮，在有條件或無條件的情況下，發出最多為期三年的規劃許可。(可參閱：場地大綱圖及場地位置圖)
3. 申請地點所在位置同時亦屬規劃指引 13F 的「第二類地區」範圍。按規劃指引 13F 的擬作「露天貯物及港口後勤用途」內說明，「第二類地區」指大多數為未有清晰規劃意向或既定的發展計劃；會受即將展開的大型基建工程所影響；坐落或鄰近《城市規劃條例》定為「現有用途」的「露天貯物或港口後勤」用地，水浸機會不高。申請人或須提交技術評估，以證明擬議用途不會對附近地區造成不良的排水、交通、視覺和環境影響。若政府部門沒有負面意見，而附近居民不予反對，或者各政府部門和附近居民所關注的問題均能透過實施規劃許可的附帶條件而獲得解決，有關申請將會獲得有效期最多 3 年的臨時規劃許可。
4. 按規劃署記錄，在申請地點所在的「住宅(丁類)」("R (D)")地帶內（即規劃指引 13F 內同一個第二類地區），申請地點的北面，最近有一宗(檔案編號：A/YL-HTF/1111)屬「露天貯物及港口後勤用途」的申請個案，於 12/3/2021 在有條件下取得臨時性質的許可。該申請面積約 7,600 平方米，較此申請的範圍大了接近十三倍，申請發展作臨時露天存放五金（為期 3 年），與此申請同屬「露天貯物或港口後勤」用途。申請人明白每一宗申請都是個別獨立的個案，並無必然的對應關係。惟該申請的性質與此申請十分接近，而申請範圍比此申請大出很多，該申請在有條件下再次取得臨時性質的許可，對此申請具有一定的參考價值。
5. 另外，在涉及同一「住宅(丁類)」("R (D)")地帶內，亦有一個申請地點，先後五次取得的規劃許可，即檔案編號：A/YL-HT/642、807、986、1070 及 A/HSK/176。撮要如下：

A/YL-HT/642 / 臨時露天存放回收紙品（為期 3 年）

A/YL-HT/807 臨時「露天存放回收紙品連附屬包裝工場」（為期 3 年）

A/YL-HT/986 / 臨時露天存放回收紙品連附屬包裝工場（為期 3 年）

A/YL-HT/1070 / 臨時露天存放建築物料和金屬製品（為期 3 年）

A/HSK/176 / 臨時露天存放建築物料和金屬製品（為期 3 年）

該場地的發展與此申請類近，最近的規劃許可以發展露天存放建築材料和金屬製品。前四次的申請位於廈村分區計劃大綱圖的「住宅(丁類)」("R (D)")和「綜合開發區」("CDA")，而最後一次位於洪水橋及廈村分區計劃大綱圖的「住宅(丁類)」("R (D)")和「政府、機構或社區」("G/IC")及「道路」("ROAD ZONE")該申請地點多次在有條件下再次取得臨時性質的許可，與此申請涉及同一「住宅(丁類)」("R (D)")地帶，對此申請具有一定的參考價值。

- 6 申請地點周圍，即與申請地點屬同一「住宅(丁類)」("R (D)")地帶的土地，有為數不少屬於「露天貯物及港口後勤用途」的發展。發展項目以露天倉地，回收物料場地、維修工場、上蓋倉庫及物流中心用途為主。申請地點發展作臨時露天存放建築材料用途，發展與周圍土地用途相近。
- 7 由於政府要落實洪水橋及廈村分區計劃大綱圖的發展，並已進行了收地，此舉影響到一些「露天貯物及港口後勤的用途」的用地。申請人提交是次申請，旨在回應業界對另覓土地繼續發展「露天貯物及港口後勤的用途」的需求。
8. 申請地點只涉及一幅私人土地，不涉政府土地。申請地點地型方正，位於半山高地，地勢平坦並已平整，由於過去已發展，無須進行任何斬樹、填泥、鑽土及隔斷水源等損害環境的開闢工作。申請地點於過去已有發展，故此基本設施齊備（水電供應）。
9. 擬議申請發展屬臨時性質，從事工作整齊，設施簡單容易還完。除標題發展外，不涉其他用途。不會在申請地點建上蓋物，不設工場，不會從事維修、噴油及清洗車輛等工作。不會發出引人注意的聲響。不會有任何損害環境設施，申請地點內不會存放易燃物品，發展項目不含有害廢料或污染物，對生態及環境不會帶來任何影響。申請人會遵從環保署署長最新發出的《處理臨時用途及露天貯存用地的環境問題作業指引》，盡量減低發展對附近可能造成的環境影響。

10. 申請地點辦公時間為星期一至星期六，每日早上八時至晚上八時，星期日及公眾假期休息。必要的運輸工作，會安排在日間非繁忙時間進行，晚上不會進行任何運輸工作。
11. 申請地點發展作臨時露天存放建築材料用途，配套設備簡單。不會建上蓋物，以露天存放的形式發展，不會有任何人在申請地點內留宿。（可參閱：場地設計圖）
12. 臨時露天存放建築材料用途，露天存放的物品以木材為主，亦會涉及金屬建材。性質屬定期存放，每天約有一次裝卸工作，涉及的運輸用量極低。
13. 發展衍生的交通流量極低，不會對附近環境構成任何負面影響。按目前營運情況估計，運輸工作平均每天一次，車流微不足道。由於進出申請地點的車輛數目極為穩定，故此車輛流量都可在預計之內。以下是申請地點的交通流量預算，詳細如下：

14. 運輸工作由一輛 5.5 噸小型貨車進行。申請地點內有足夠土地，供上貨或卸貨工作，絕不會對附近交通構成影響。

15. 申請地點會為 5.5 噸小型貨車設置上落貨車位。上落貨車位面積 11 米 X 3.5 米，佔面積 38.5 平方米。上落貨車位供小型貨車短暫停泊上落貨。除了上述車輛外，不會有任何車輛出入申請地點，或使用申請地點內設的泊車位。由於申請地點只有一輛貨車使用，出入申請地點的車流極少，任何時間均不會出現車輛輪候或阻塞交通的情況，對附近交通不會構成影響。

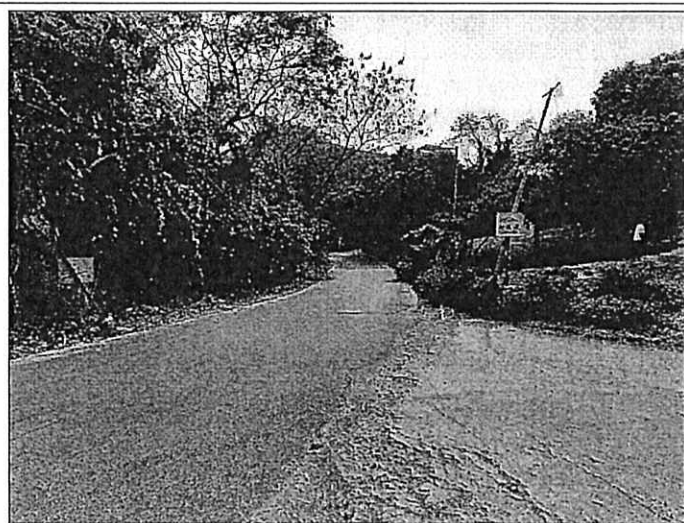
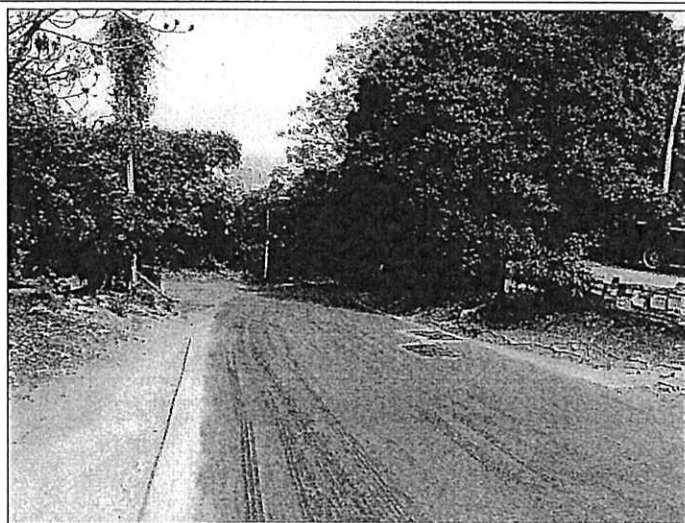
19. 出入口設於申請地點東南面，出入口（閘門）闊度約 7 米，位置均寬敞明確，有足夠空間供如消防車之類的緊急車輛進入。

20. 申請地點有行車通道連接雞伯嶺路，經由一段雞伯嶺路再連接鳳降村路，接通新界道路網。行車通道已使用多年，為一條山邊現有村路，少有行人，長度約五十米，車道平坦沒有彎位，平均闊度約 4.5 米，路面早已平整。而且沿路亦有一些避車位置，相信行車通道可供 5.5 噸小型貨車安全使用。行車通道屬公眾通道，使用者與業主會參與管理、維修及補養等工作。

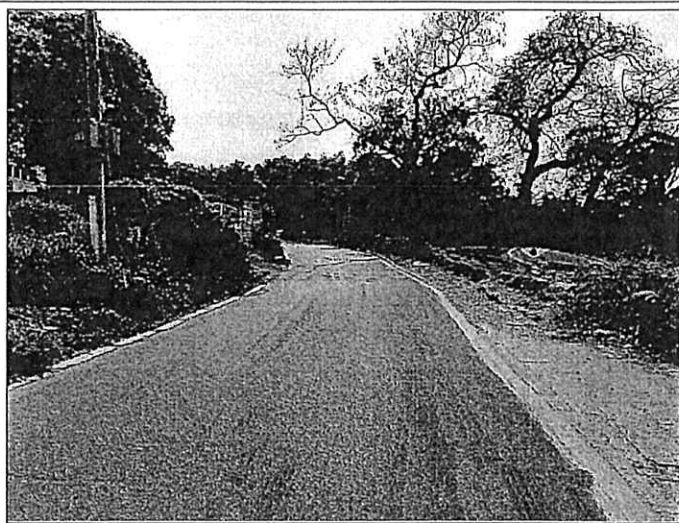

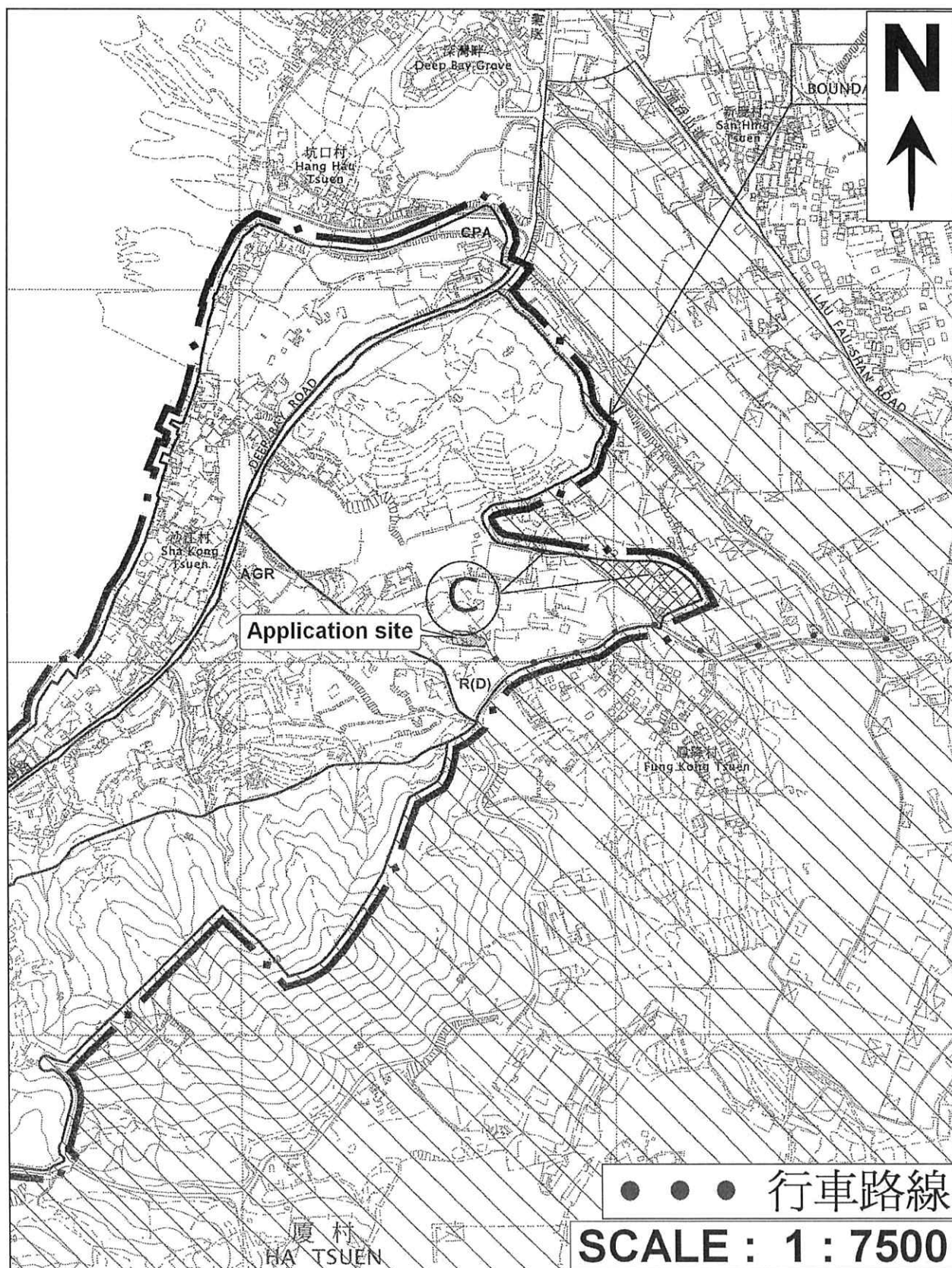

21. 申請人會聘請具經驗公司協助，在申請地點實施所有附帶條件工程，包括綠化、渠務、消防裝置及舒緩環境措施工作。落實執行的附帶條件工程，能加強地區綠化，有效降低水浸的機會，同時改善環境衛生。相信各政府部門和附近居民所關注的問題，都能透過實施上述附帶條件而得到解決。
22. 申請人願意承擔場內所有附帶條件設施的興建和維修保養責任。為防止出現阻塞及狀況變壞，申請人會安排專人定期檢驗及維修排水設施，並按時清理沙井內的雜物，確保有關設施能運作良好，不會令申請地點及鄰近地區出現水浸問題。
23. 申請地點範圍屬集體政府租契批租的舊批農地。此申請獲通過後，申請人會依足規定，就申請地點上搭建構築物，向地政總署元朗地政專員申請短期豁免書（STW），包括繳付地價或費用。

Relevant extract of the Town Planning Board Guidelines for
Application for Open Storage and Port Back-up Uses
(TPB PG-No. 13F)

1. On 27.3.2020, the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance (TPB PG-No. 13F) were promulgated, which set out the following criteria for the various categories of area:
 - (a) Category 1 areas: favourable consideration will normally be given to applications within these areas, subject to no major adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions. Technical assessments should be submitted if the proposed uses may cause significant environmental and traffic concerns;
 - (b) Category 2 areas: planning permission could be granted on a temporary basis up to a maximum period of 3 years, subject to no adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions. Technical assessments, where appropriate, should be submitted to demonstrate that the proposed uses would not have adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas;
 - (c) Category 3 areas: applications would normally not be favourably considered unless the applications are on sites with previous planning approvals (irrespective of whether the application is submitted by the applicant of previous approval or a different applicant). Sympathetic consideration may be given if genuine efforts have been demonstrated in compliance with approval conditions of the previous planning applications and relevant technical assessments/proposals have been included in the fresh applications, if required, to demonstrate that the proposed uses would not generate adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas. Planning permission could be granted on a temporary basis up to a maximum period of 3 years, subject to no adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions; and
 - (d) Category 4 areas: applications would normally be rejected except under exceptional circumstances. For applications on sites with previous planning approvals (irrespective of whether the application is submitted by the applicant of previous approval or a different applicant), and subject to no adverse departmental comments and local objections, sympathetic consideration may be given if genuine efforts have been demonstrated in compliance with approval conditions of the previous planning applications and relevant technical assessments/proposals have been included in the fresh applications, if required, to demonstrate that the proposed uses would not generate adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas. The intention is however to encourage the phasing out of such non-conforming uses as early as possible. A maximum period of 2 years may be allowed upon renewal of planning permission for an applicant to identify suitable sites for relocation. No further renewal of approval will be given unless under very exceptional circumstances and each application for renewal of approval will be assessed on its individual merit.

2. In assessing applications for open storage and port back-up uses, the other major relevant assessment criteria are also summarised as follows:
- (a) the use of sites of less than 1,000 m² each for open storage uses and 2,000 m² each for port back-up uses in rural areas is generally not encouraged, other than sites located in major road corridors, industrial/godown/workshop areas, quarrying activities or where it is demonstrated that optimum use is made of the site. This is to prevent the further proliferation of small sites in rural areas, minimising sprawl over countryside areas and reducing travel trips;
 - (b) port back-up sites and those types of open storage uses generating adverse noise, air pollution, visual intrusion and frequent heavy vehicle traffic should not be located adjacent to sensitive receivers such as residential dwellings, hospitals, schools and other community facilities;
 - (c) port back-up uses are major generators of traffic, with container trailer/tractor parks generating the highest traffic per unit area. In general, port back-up sites should have good access to the strategic road network, or be accessed by means of purpose built roads;
 - (d) adequate screening of the sites through landscaping and/or fencing should be provided where sites are located adjacent to public roads or are visible from surrounding residential areas;
 - (e) there is a general presumption against conversion of agricultural land and fish ponds to other uses on an ad-hoc basis, particularly in flood prone areas or sites which would obstruct natural drainage channels and overland flow; and
 - (f) for applications involving sites with previous planning approvals, should there be no evidence to demonstrate that the applicants have made any genuine effort to comply with the approval conditions of the previous planning applications, planning permission may be refused, or a shorter compliance period for the approval conditions may be imposed, notwithstanding other criteria set out in the Guidelines are complied with.

I would draw your attention to the Minutes of 12 June 2020 for Open Storage on R zoning in the same district:

94. A Member noted that there were a number of planning applications for temporary open storage and port back-up uses **within the HSK/HT NDA** and raised concern if there was any implication on the implementation of the NDA. In response, the Chairman said that noting the changes in planning circumstances in the rural New Territories, the Town Planning Board had revised the TPB PG-No. 13E in March 2020 to set out a general approach for assessing planning applications for open storage and port back-up uses in NDAs during the interim period before the site was required for NDA development. In general, sympathetic consideration might be given to applications for continued operation of open storage and port back-up uses during the interim period.

Advisory clauses

- (a) to resolve any land issues relating to the development with the concerned owner(s) of the Site;
- (b) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD) that if the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of the Building Authority (BA), they are unauthorized building works (UBW) under the Buildings Ordinance (BO). For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with the prevailing enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the application site under the BO. Before any demolition works are to be carried out on the Site, prior approval and consent of the BA shall be obtained. An Authorized Person should be appointed as the co-ordinator for any demolition works in accordance with the BO. Should the AP confirm the works fall into the Minor Works Control System (MWCS), then the applicant may proceed with the works under the MWCS. For details of the submission procedure under the MWCS, the applicant may wish to visit his website at www.bd.gov.hk;
- (c) to note the comments of the Director of Environmental Protection (DEP) that the applicant is advised to follow the latest 'Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites' issued by the DEP to minimize potential environmental nuisance to the surrounding area;
- (d) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD) that adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains. HyD shall not be responsible for the maintenance of any access connecting the Site and Kai Pak Ling Road;
- (e) to note the comments of the Antiquities and Monuments Office, Development Bureau (AMO, DevB) that the applicant is required to inform AMO immediately in case any antiquities or supposed antiquities under the Antiquities and Monuments Ordinance (Cap. 53) are discovered in the course of works; and
- (f) to note the comments of the Director of Fire Services (D of FS) that in consideration of the design/nature of the proposal, fire service installations (FSIs) are anticipated to be required. Therefore, the applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. In addition, the applicant should also be advised that the layout plans should be drawn to scale and depicted with dimensions and nature of occupancy and the location of where the proposed FSI to be installed should be clearly marked on the layout plans. The applicant should also adhere to **Appendix VI** for the good practice guidelines for open storage. However, the applicant is reminded that if the proposed structure(s) is required to comply with the BO (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans.
