- 4. 按規劃署記錄,在申請地點所在的「住宅(丁類)」("R(D)")地帶內(即規劃 指引 13F內同一個第二類地區),申請地點的北面,最近有一宗(檔案編 號:A/YL-HTF/1111)屬「露天貯物及港口後勤用途」的申請個案,於 12/3/2021 在有條件下取得臨時性質的許可。該申請面積約 7,600 平方米, 較此申請的範圍大了接近十三倍,申請發展作臨時露天存放五金(為期 3 年),與此申請同屬「露天貯物或港口後勤」用途。申請人明白每一宗申請 都是個別獨立的個案,並無必然的對應關係。惟該申請的性質與此申請十 分接近,而申請範圍比此申請大出很多,該申請在有條件下再次取得臨時 性質的許可,對此申請具有一定的參考價值。
- 另外,在涉及同一「住宅(丁類)」("R (D)")地帶內,亦有一個申請地點,先 後五次取得的規劃許可,即檔案編號: A/YL-HT/642、807、986、1070 及 A/HSK/176。撮要如下:

A/YL-HT/642/臨時露天存放回收紙品(為期3年) A/YL-HT/807 臨時「露天存放回收紙品連附屬包裝工場」(為期3年) A/YL-HT/986/臨時露天存放回收紙品連附屬包裝工場(為期3年) A/YL-HT/1070/臨時露天存放建築物料和金屬製品(為期3年) A/HSK/176/臨時露天存放建築物料和金屬製品(為期3年)

該場地的發展與此申請類近,最近的規劃許可以發展露天存放建築材料和 金屬製品。前四次的申請位於廈村分區計劃大綱圖的「住宅(丁類)」("R (D)")和「綜合開發區」("CDA"),而最後一次位於洪水橋及厦村分區計劃大 綱圖的「住宅(丁類)」("R (D)")和「政府、機構或社區」("G/IC")及「道 路」("ROAD ZONE")該申請地點多次在有條件下再次取得臨時性質的許 可,與此申請涉及同一「住宅(丁類)」("R (D)")地帶,對此申請具有一定的 參考價值。

- 6 申請地點周圍,即與申請地點屬同一「住宅(丁類)」("R(D)")地帶的土地, 有為數不少屬於「露天貯物及港口後勤用途」的發展。發展項目以露天倉 地,回收物料場地、維修工場、上蓋倉庫及物流中心用途為主。申請地點 發展作臨時露天存放建築材料用途,發展與周圍土地用途相近。
- 7 由於政府要落實洪水橋及厦村分區計劃大綱圖的發展,並已進行了收地, 此舉影響到一些「露天貯物及港口後勤的用途」的用地。申請人提交是次 申請,旨在回應業界對另覓土地繼續發展「露天貯物及港口後勤的用途」 的需求。
- 申請地點只涉及一幅私人土地,不涉政府土地。申請地點地型方正,位於 半山高地,地勢平坦並已平整,由於過去已發展,無須進行任何斬樹、填 泥、鑽土及隔斷水源等損害環境的開闢工作。申請地點於過去已有發展, 故此基本設施齊備(水電供應)。
- 9. 擬議申請發展屬臨時性質,從事工作整齊,設施簡單容易還完。除標題發展外,不涉其他用途。不會在申請地點建上蓋物,不設工場,不會從事維修、噴油及清洗車輛等工作。不會發出引人注意的聲響。不會有任何損害環境設施,申請地點內不會存放易燃物品,發展項目不含有害廢料或污染物,對生態及環境不會帶來任何影響。申請人會遵從環保署署長最新發出的《處理臨時用途及露天貯存用地的環境問題作業指引》,盡量減低發展對附近可能造成的環境影響。

- 申請地點辦公時間為星期一至星期六,每日早上八時至晚上八時,星期日 及公眾假期休息。必要的運輸工作,會安排在日間非繁忙時間進行,晚上 不會進行任何運輸工作。
- 申請地點發展作臨時露天存放建築材料用途,配套設備簡單。不會建上蓋物,以露天存放的形式發展,不會有任何人在申請地點內留宿。(可參閱:場地設計圖)
- 12. 臨時露天存放建築材料用途,露天存放的物品以木材為主,亦會涉及金屬 建材。性質屬定期存放,每天約有一次裝卸工作,涉及的運輸用量極低。
- 13. 發展衍生的交通流量極低,不會對附近環境構成任何負面影響。按目前營 運情況估計,運輸工作平均每天一次,車流微不足道。由於進出申請地點 的車輛數目極為穩定,故此車輛流量都可在預計之內。以下是申請地點的 交通流量預算,詳細如下:




- 15. 申請地點會為 5.5 噸小型貨車設置上落貨車位。上落貨車位面積 11 米 X 3.5 米,佔面積 38.5 平方米。上落貨車位供小型貨車短暫停泊上落貨。除 了上述車輛外,不會有任何車輛出入申請地點,或使用申請地點內設的泊 車位。由於申請地點只有一輛貨車使用,出入申請地點的車流極少,任何 時間均不會出現車輛輪候或阻塞交通的情況,對附近交通不會構成影響。








- 21. 申請人會聘請具經驗公司協助,在申請地點實施所有附帶條件工程,包括 緣化、渠務、消防裝置及紓緩環境措施工作。落實執行的附帶條件工程, 能加強地區緣化,有效降低水浸的機會,同時改善環境衛生。相信各政府 部門和附近居民所關注的問題,都能透過實施上述附帶條件而得到解決。
- 22. 申請人願意承擔場內所有附帶條件設施的興建和維修保養責任。為防止出現阻塞及狀況變壞,申請人會安排專人定期檢驗及維修排水設施,並按時清理沙井內的雜物,確保有關設施能運作良好,不會令申請地點及鄰近地區出現水浸問題。
- 23. 申請地點範圍屬集體政府租契批租的舊批農地。此申請獲通過後,申請人 會依足規定,就申請地點上搭建構築物,向地政總署元朗地政專員申請短 期豁免書(STW),包括繳付地價或費用。
- 24. 申請地點會委託專業管理公司負責管理,按時派員收集和清理垃圾,嘖灑 防蚊藥水,確保環境衛生及美觀。相信申請地點發展後,亦能繼續與社區 保持和諧。在完善管理下,亦可避免土地荒廢或被人胡亂傾倒泥頭或癈 物,減少細菌及蚊蟲滋生的可能。
- 25. 此申請能有意義及靈活地善用地點資源,善用鄉郊土地。政府亦可將發展納入規管,有助於抑制同區其他違規發展,對規劃及環境均帶有好處及產生正面作用。

26. 此申請經過周詳計劃,顧慮周全,對各方面都能平衡及協調,不會對規劃 及地方環境帶來負面影響。於提交申請前,申請人已廣泛向地區人士徵詢 意見,區內人士對擬議發展並無反對意見。城規會可在規劃許可加入適當 的附帶條件和指引性質條款,盡量減少擬議發展對環境可能造成的影響。 場地大綱圖

Relevant extract of the Town Planning Board Guidelines for <u>Application for Open Storage and Port Back-up Uses</u> (TPB PG-No. 13F)

- 1. On 27.3.2020, the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance (TPB PG-No. 13F) were promulgated, which set out the following criteria for the various categories of area:
 - (a) Category 1 areas: favourable consideration will normally be given to applications within these areas, subject to no major adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions. Technical assessments should be submitted if the proposed uses may cause significant environmental and traffic concerns;
 - (b) Category 2 areas: planning permission could be granted on a temporary basis up to a maximum period of 3 years, subject to no adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions. Technical assessments, where appropriate, should be submitted to demonstrate that the proposed uses would not have adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas;
 - (c) Category 3 areas: applications would normally not be favourably considered unless the applications are on sites with previous planning approvals (irrespective of whether the application is submitted by the applicant of previous approval or a different applicant). Sympathetic consideration may be given if genuine efforts have been demonstrated in compliance with approval conditions of the previous planning applications and relevant technical assessments/proposals have been included in the fresh applications, if required, to demonstrate that the proposed uses would not generate adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas. Planning permission could be granted on a temporary basis up to a maximum period of 3 years, subject to no adverse departmental comments and local objections, or the concerns of the departments and local residents can be addressed through the implementation of approval conditions; and
 - (d) Category 4 areas: applications would normally be rejected except under exceptional circumstances. For applications on sites with previous planning approvals (irrespective of whether the application is submitted by the applicant of previous approval or a different applicant), and subject to no adverse departmental comments and local objections, sympathetic consideration may be given if genuine efforts have been demonstrated in compliance with approval conditions of the previous planning applications and relevant technical assessments/proposals have been included in the fresh applications, if required, to demonstrate that the proposed uses would not generate adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas. The intention is however to encourage the phasing out of such non-conforming uses as early as possible. A maximum period of 2 years may be allowed upon renewal of planning permission for an applicant to identify suitable sites for relocation. No further renewal of approval will be given unless under very exceptional circumstances and each application for renewal of approval will be assessed on its individual merit.

- 2. In assessing applications for open storage and port back-up uses, the other major relevant assessment criteria are also summarised as follows:
 - (a) the use of sites of less than 1,000 m² each for open storage uses and 2,000 m² each for port back-up uses in rural areas is generally not encouraged, other than sites located in major road corridors, industrial/godown/workshop areas, quarrying activities or where it is demonstrated that optimum use is made of the site. This is to prevent the further proliferation of small sites in rural areas, minimising sprawl over countryside areas and reducing travel trips;
 - (b) port back-up sites and those types of open storage uses generating adverse noise, air pollution, visual intrusion and frequent heavy vehicle traffic should not be located adjacent to sensitive receivers such as residential dwellings, hospitals, schools and other community facilities;
 - (c) port back-up uses are major generators of traffic, with container trailer/tractor parks generating the highest traffic per unit area. In general, port back-up sites should have good access to the strategic road network, or be accessed by means of purpose built roads;
 - (d) adequate screening of the sites through landscaping and/or fencing should be provided where sites are located adjacent to public roads or are visible from surrounding residential areas;
 - (e) there is a general presumption against conversion of agricultural land and fish ponds to other uses on an ad-hoc basis, particularly in flood prone areas or sites which would obstruct natural drainage channels and overland flow; and
 - (f) for applications involving sites with previous planning approvals, should there be no evidence to demonstrate that the applicants have made any genuine effort to comply with the approval conditions of the previous planning applications, planning permission may be refused, or a shorter compliance period for the approval conditions may be imposed, notwithstanding other criteria set out in the Guidelines are complied with.

I would draw your attention to the Minutes of 12 June 2020 for Open Storage on R zoning in the same district:

94. A Member noted that there were a number of planning applications for temporary open storage and port backup uses within the HSK/HT NDA and raised concern if there was any implication on the implementation of the NDA. In response, the Chairman said that noting the changes in planning circumstances in the rural New Territories, the Town Planning Board had revised the TPB PG-No. 13E in March 2020 to set out a general approach for assessing planning applications for open storage and port back-up uses in NDAs during the interim period before the site was required for NDA development. In general, sympathetic consideration might be given to applications for continued operation of open storage and port back-up uses during the interim period.

Before any demolition works are to be carried out on the Site, prior approval and consent of the BA shall An Authorized Person should be appointed as the co-ordinator for any be obtained. demolition works in accordance with the BO. Should the AP confirm the works fall into the Minor Works Control System (MWCS), then the applicant may proceed with the works under the MWCS. For details of the submission procedure under the MWCS, the applicant may wish to visit his website at www.bd.gov.hk;
- (c) to note the comments of the Director of Environmental Protection (DEP) that the applicant is advised to follow the latest 'Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites' issued by the DEP to minimize potential environmental nuisance to the surrounding area;
- (d) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD) that adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to nearby public roads/drains. HyD shall not be responsible for the maintenance of any access connecting the Site and Kai Pak Ling Road;
- (e) to note the comments of the Antiquities and Monuments Office, Development Bureau (AMO, DevB) that the applicant is required to inform AMO immediately in case any antiquities or supposed antiquities under the Antiquities and Monuments Ordinance (Cap. 53) are discovered in the course of works; and
- (f) to note the comments of the Director of Fire Services (D of FS) that in consideration of the design/nature of the proposal, fire service installations (FSIs) are anticipated to be required. Therefore, the applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. In addition, the applicant should also be advised that the layout plans should be drawn to scale and depicted with dimensions and nature of occupancy and the location of where the proposed FSI to be installed should be clearly marked on the layout plans. The applicant should also adhere to Appendix VI for the good practice guidelines for open storage. However, the applicant is reminded that if the proposed structure(s) is required to comply with the BO (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans.
