I refer to the captioned planning application.

Please find below departmental comments:

## <u>Transport Department (Contact Person: Mr. Phil CAI; Tel.: 2399</u> 2421)

- (a) The applicant should provide trip generation and attraction due to the development and assess the traffic impact to Chi Ho Road and the local access.
- (b) The applicant should justify the no. of parking and loading/ unloading considering the commute of staff/ visitors and logistics.
- (c) The applicant should note the local access between Chi Ho Road and the site is not managed by his department.

## <u>Drainage Services Department (Contact Person: Mr. Terence TANG; Tel.: 2399 1257)</u>

Since the land coverage area at about 3.49 hectare is large, a Drainage Impact Assessment (DIA) should be conducted pertaining to the subject application as it is important to ensure adequate drainage facilities will be provided.

Fire Services Department (Contact Person: Mr. WONG Ho-yin; Tel.: 2733 7737)

Please advise the applicant to provide clarification on the nearest vehicular access to the subject site for their further consideration.

<u>Environmental Protection Department (Contact Person: Ms. Ming HE; 2835 2390)</u>

- (a) whether public announcement system or any form of audio amplification system will be used on the site.
- (b) the proposed sewage handling method for sewage collection, treatment and disposal, e.g. septic tank and soakaway system, portable toilet
- (c) the number of barbecue pits will be proposed at the Site Landscape Unit of Planning Department (Contact Person: Mr. Samuel HUI; Tel.: 3565 3957)

According to the layout provided in the application, 6 fish ponds and a plant nursery (i.e. 和平紀念林) are proposed within the site. The proposed layout may be in conflict with the existing trees. No tree information, proposed tree treatment and mitigation measures are provided. Potential impact on the existing landscape resources within the site cannot be reasonably ascertained.

- (a) The applicant is advised to provide information on the existing trees within the application site including location, species and sizes, general condition with photos, proposed tree treatment and mitigation measures for consideration.
- (b) According to the applicant's supplementary letter (dated 22.6.2023), excavation of land is not required. However, it is noted that 6 fish ponds are proposed which excavation of land is anticipated. The applicant is advised to clarify.
- (c) The applicant should be advised that approval of the application does not imply approval of tree works such as pruning, transplanting and felling under lease. The applicant is reminded to seek approval for any proposed tree works from relevant departments prior to commencement of the works.

Fanling, Sheung Shui and Yuen Long East District Planning Office (Contact Person: Ms. Loree DUEN; Tel.: 3168 4037)

(a) Noting that the Site is with an area of about 34,900 sqm, the applicant should provide justifications on the operational need of the proposed use in extensive area.

- (b) Please clarify if there is any filling of pond in the application site.
- (c) Please provide operational details of the proposed use, such as the funding source and the number of staff required, and whether consent from relevant land owners are acquired.
