

本人是本團體董事及場主,自二零零八年起,本人以「Kelly Animals Shelter」名義 一直致力從事救助和收養遺棄及流浪動物的工作、向公眾推廣尊重生命、愛護動物 的訊息。二零一三年,本團體成立並根據《税務條例》(香港法例第112章)第88 條獲稅務局認可為豁免繳税的慈善機構。對本團體而言,生命皆珍貴:這理念驅使 本團體默默耕耘,不論疾病老幼,只要本團體行有餘力均會協助和接收。樣子討喜 的幼貓幼狗從出生不久眼未睜開後數個月已經落戶好人家;尚未遇到下個家的,本 團體一直照顧絕不離棄。

#### 目前場內運作及困難

現時本團體在該地有逾二百五十隻寄養貓狗待有心人領養或暫託,當中以成年唐狗為主。場主每天都要花上整天時間及心力去完成所有場務,基本如籠舍清潔、提供乾淨食水、檢查貓狗狀況、安排領養程序等;複雜如為未能自理幼犬幼貓每兩小時 餵奶、處理上門求助個案、患病動物清理傷口、餵藥、外出求診等。場務之重,即 使假日較多熱心人士到場幫忙,也令場主不時嘆息一天只有二十四小時…… 疫情影響由二零二零至今從不間斷,但以上場務場主每天一定要完成,不可因疫情 停擺,亦不可能像一般工作可以放假休息。疫情下為配合防疫,義工人數大減,人 手及資源更見緊拙,令場務重擔雪上加霜。

本團體亦明白資源及人手嚴重不足,但也只得繼續堅持。每次救助也來得緊急,基本上可說是來者不能拒,「拒」的話貓狗何去何從,「接收」起碼不用流離失所。 令場主及義工們繼續接收貓狗的推動力,是因為好多貓狗收留後,成功被領養回 家,心裡感到萬般安慰。如果本團體當時沒收留,今時今日這些貓狗未必有機會遇 到寵愛牠們的新主人。場內人手長期不足,有時場主已經沒能抽空外出拯救貓狗, 仍會有求助者直接把貓狗送來,親自安頓於場內。場主定期也要親身帶貓狗睇醫 生,基本上生活都圍繞住場內貓狗,沒有個人/家庭生活,沒有一點娛樂,全部時 間都是不停為貓狗付出。即使場主自己高血壓被醫生建議即時入院,也拒絕留院, 全因場主心痛場內毛寶貝只靠少數義工照顧,未必足夠。場主亦曾因照顧新求助個 案的狗狗而被咬傷至手皮開肉綻不能癒合。遺憾的是,場主因場內人手不足而沒能 立即入院縫針。直到數日後,假日到場義工不忍場主傷口開始發黑,不停敦促場主 立即就醫。有次場主腳傷行走不便,但因有善心人士入場領養,場主即使步履蹒跚 亦帶領養人行畢全場介紹毛寶貝,只盼窒多一位毛寶貝被選中。



場內病狗情況及例子

場內十歲以上年老貓狗目前為止亦超過一百一十隻,所以即使場主悉心照顧場內眾 多貓狗,牠們都難敵歲月洗禮,徐徐老去逝去。場主篤信佛教,貓狗生病亦絕不放 棄治療,盼望盡一切最大可能讓牠們得到較好的照顧。即使遇上絕症、急病,本團 體亦積極安排治療及護理/尋找暫托家庭,皆因場內所有貓狗都是本團體的毛寶 貝。現由眾多個案抽取少量個案資料,希望令貴署更了解場內病狗情況:







除了媒體上的推廣,疫情前亦有不同學生組織(包括中小學、大學學生會 e.g 香港 中文大學學牛會社會科學院(大類收牛)學牛會幹事會內閣 社楹 SOCFERO: YMCA 大 學青年會等)及家庭入場體驗做義工。雖然入場體驗義工未必完全減輕場主護理狗 狗的重擔,但場主深信是最好的推廣方法。親身體驗可令更多香港人鳳受流浪毛孩 的可愛、洗去流浪狗傳統的壞印象(如具攻擊性、有傳染病等)、學習正確與狗狗 相處方法及認識唐狗的優點等。場主的教育工作亦大大加深香港人領養不棄養的觀 念,亦有體驗義工因此即日領養。即使未有即日領養,亦有義工後來在經濟能力許 可下,再次入場領養。另外,在情況許可下,本團體亦安排外出領養日,加強推廣 教育及狗狗被領養機會:

此外,如上文提及,在短短兩年間,本團體已成功為超過二百隻狗狗回家。當中亦 有一些難被領養的年老狗狗及殘缺狗狗。疫情下,本團體接收的求助個案增加,當 中不少是因被數間流浪狗舍拒絕的絕望求助。本團體深明其他流浪狗舍因疫情肆虐 而暫停一切救援工作,是非常痛心的決定。此信初段亦提及本團體在種種原因下難 以推卻求助個案。

#### 本團體是次申請及搬遷困難

本團體有幸得到過百位香港人熱心幫助,於二零二零年初遷入並開始佔用該地作動 物寄居場所用途。



惜遷入後即受到 2019 冠狀病毒病肆虐影響,在一直實行的社交距離措施下缺乏義 工處理事務。本團體資源有限,義工人手及各方面都捉襟見肘,2019 冠狀病毒病 疫情更使本團體在爭取和調配資源運作方面舉步維艱。收到貴署執法部門該信函 前,本團體已安排義工與貴署溝通以臻處理該地土地用途的事宜,亦自去年七月起 積極尋找其他合適土地,包括空置及可供租用作動物寄居場所用途的政府土地和私 人用地。然而,本團體缺乏相關方面的知識,僅餘的義工亦未必能兼顧本團體的事 務,以致上述事情的跟進上未如預期,本團體亦落入進退維谷的境地。

本團體十分重視該申請,亟需該申請獲城市規劃委員會批准從而延續本團體護養動物的使命。貴署想必能從與本團體義工就該申請的進度以及所需文件的討論感受到本團體推動該申請的熱切。本團體毛寶貝的開支龐大,醫療費用高昂,貴署執法部門該信函中提及之罰款,大大增加開支重擔。倘若本團體無可奈何下要於限期本年四月二十二日前遷出,本團體的運作將會慘遭打擊,不敢想像。本團體在2019冠狀病毒病疫情陰霾下亦難以抽撥資源在短期內另覓良地及遷離該地。

如蒙盡速安排審核該申請,以使本團體能繼續在該地的慈善活動,本團體不勝感激。

Thanks for your help so far. As discussed, please refer to below clarification regarding KAS application:

1. 獨立廁間 (Standalone WC): it is connected to septic tank and shall be regarded as structure in the application. Hence following information provided in application form submitted earlier shall be revised as follow:

- Page 5 - section 6c - Proposed number of buildings: 12

- Page 11 - Gist of application - (ii) No. of block - Non-domestic: 12

Remarks: Given the 2 standalone WCs are located under the covered area # 6 in the attached Layout Plan, no changes to the Proposed GFA and Proposed covered land area are required. The Layout plan is however revised to include the dimension of 2 standalone WCs.

2. Average daily traffic flow: there are around 5 vehicles in and out of the application site.







However, KAS noted that serious subsidence is observed at various parts of the site and the previous tenant already filled those parts of the site with cement when KAS came into possession of the site. Operating on limited resources and with a view to maximising the use of such existing cement surfaced land (as elaborated below), the cement surfaced land and the U- channels in the immediate vicinity of the cement surfaced ground are kept since the cement surfaced ground facilitates the flow of storm water and waste water to the respective U- channels.
		Having done so, structures numbered 1 to 5 and 7 to 12 on the layout plan have been erected on the foundation and support of the relevant part of the land filled with cement by the previous tenant, and the septic tank is constructed.
		The cement surfaced ground next to the sewage U-channels are also utilised to set up the enclosures of dogs. This does not only minimise the use of cement-filling on the site, but also provides a favourable platform to set up enclosures of the dogs compared to a muddy/soil ground, for the reasons below:

 a. it is more hygienic as the surface can be cleaned and washed more thoroughly;

b. it is less favourable for germs and pests to accumulate on the cement surface;

c. a cement surfaced ground provides stronger foundation for erecting fences constituting the enclosures. Otherwise the enclosures will easily collapse on its own or upon being pushed by the dogs, causing unwanted injuries; and

d. with strong enclosures set up on the cement surfaced ground, KAS provides shelter for stray dogs which are large and sometimes aggressive such as Rottweiler and Husky and they are being kept in a segregated zone (as elaborated in the paragraph below) to reduce the risk of unwanted injuries inflicted by these dogs to other animals on the site. This enables KAS to provide shelter, assistance and safety to a broader range of dogs and animals.

The enclosures are set up on the cement surfaced ground on both sides of the sewage U-channels. The fences of these enclosures form the inner boundaries of the several zones within structure no.6 along the sewage U-channels. The opening of the enclosures lead to a large area in the zone which is the activity area for dogs. One of these zones is used to keep the large and aggressive dogs as mentioned above, and other zones are used to keep other large sized adult dogs which are generally mongrels. These dogs need space to move about which is crucial for their mental health and is an essential part of their basic animal welfare.

The extent of land filling and excavation is constrained to a minimum and alternatives are actively pursued in areas which have lesser degree of subsidence concerns. For example, the activity area for dogs referred to in the preceding paragraph (which accounts for a significant portion of the site) is paved with tiles without plasters of cement (as shown in the layout plan).

We refer to certain comments from the public in respect of the captioned application and set out our response as follows:

No.	Comments from the public	Response from Kelly Animals Shelter (KAS)
1.	Rodents roam around the site, in groups and even in broad daylight, scouring the garbage for food.	Rodent activities in the neighbourhood of the site (e.g. pig farm, refuse collection point and nearby establishments) has been the concern of KAS and hence KAS contacted the Food and Environmental Hygiene Department in late 2021 for advice and assistance on reducing rodent activity. KAS is committed to minimize rodent activity as urine from rodents is a common agent for transmitting leptospirosis to dogs on site, which is a highly infectious bacterial disease that affects both humans and animals. Leptospirosis is a very serious disease to our dogs given it can cause acute kidney and/or liver failure with permanent damage, with medium chance of survival under aggressive and expensive treatment such as dialysis. Hence, it has been KAS's top priority to rodent activity onsite given the daunting and irreversible consequence to, and heavy medical burden on, dogs on the site. There has since been very low to nil rodent activity on the site, as a result of the following: (a) the site (including the U-channels) is cleaned up regularly with pet-friendly garbage enzymes (環保酵素) and fences are applied inside the U-channels to fence off access by rodents;



(b) garbage generated on the site is collected by closed-lid

point for multiple times every day;

## 2. Garbage and articles accumulate on the site including at the entrance and garbage accumulated at the entrance is only dumped once a week, causing serious sanitary concerns.

KAS does not identify any such hazards because:

### 聯署要求通過臨時動物寄養所及有關工程的規劃申請(A/YL-LFS/423)

我們是一群支持下列規劃申請的動物義工和社會各界人士,特此向城市規劃委員會聯署要求通過臨時動物寄養所(為期3年)以及填土及挖土工程的第16條規劃申請(下稱"申請")(申請編號: A/YL-LFS/423)。

流浪動物及遺棄動物問題是本港各界一直需要正視的社會議題。跟據資料,漁 護署每年處理約五千至七千隻流浪狗。有關部門於 2011 年處理了總共 5800 頭 流浪狗及 3557 隻流浪貓,當中只有 852 隻狗和 205 隻貓經動物福利團體安排領 養。<sup>^1</sup>這些未能找到領養家庭的動物大部份會被人道毀滅。而動物收容機構 在此議題是十分重要的角色,可惜這些機構的數量一直不足以應對流浪動物的 問題,主因是這類動物拯救及收容工作需要大量資源及土地,亦需當局大力支 持。

申請人 Kelly Animals Shelter (下稱 "KAS") 是根據《税務條例》(香港法例第 112 章) 第 88 條獲稅務局認可為豁免繳税的慈善機構,作為非政府動物救助慈善機 構,致力救助本港的流浪狗及被遺棄動物,並以不人道毀滅動物作原則,向公 眾推廣愛護動物和尊重生命的訊息及藉著提供義工服務機會及活動教育市民。 回應上述本港流浪動物問題,申請團體的成立旨在拯救流浪及被遺棄動物,正 正是在此社會問題上以民間的角色積極提供協助。該團體亦十分需要場地收容 被救動物,以陸續安排合適的領養家庭領養場內暫住的被救動物。

此申請涉及的地盤面積僅佔流浮山及尖鼻咀分區計劃大綱圖的總綠化地帶面積約0.13%,相信這項規劃申請對當區的整體規劃及綠化地帶的不良影響實在是微不足道。另外,往來申請地點的道路交通量低,訪客和義工主要載搭現行公共小巴來往該處,可見申請不會為當區交通帶來額外負擔。加上該申請地點遠離市區,而附近只有極少量居民,附近亦已有動物相關的土地用途(例如養豬場),相信此申請不會影響當區環境及民生。反觀通過申請對社會有莫大貢獻,KAS 主要希望透過使用這片土地用作拯救及收容動物,同時向大眾推廣愛護動物的正面訊息。此舉除減輕漁護署在處理動物方面的負擔,亦能在社會層面以及協助減輕流浪動物問題上帶來裨益。

就以上各點,我們懇請 貴委員會通過此規劃申請。

# Extract of Town Planning Board Guidelines for Application for Development within Green Belt Zone <u>under Section 16 of the Town Planning Ordinance</u> (TPB PG-No. 10)

The relevant assessment criteria are as follows:

- (a) There is a general presumption against development (other than redevelopment) in a "Green Belt" ("GB") zone. In general the Board will only be prepared to approve applications for development in the context of requests to rezone to an appropriate use.
- (b) An application for new development in a "GB" zone will only be considered in exceptional circumstances and must be justified with very strong planning grounds. The scale and intensity of the proposed development including the plot ratio, site coverage and building height should be compatible with the character of surrounding areas. With the exception of New Territories Exempted Houses, a plot ratio up to 0.4 for residential development may be permitted.
- (c) Applications for New Territories Exempted Houses with satisfactory sewage disposal facilities and access arrangements may be approved if the application sites are in close proximity to existing villages and in keeping with the surrounding uses, and where the development is to meet the demand from indigenous villagers.
- (d) Redevelopment of existing residential development will generally be permitted up to the intensity of the existing development.
- (e) Applications for government/institution/community (G/IC) uses and public utility installations must demonstrate that the proposed development is essential and that no alternative sites are available. The plot ratio of the development site may exceed 0.4 so as to minimize the land to be allocated for G/IC uses.
- (f) Passive recreational uses which are compatible with the character of surrounding areas may be given sympathetic consideration.
- (g) The design and layout of any proposed development should be compatible with the surrounding area. The development should not involve extensive clearance

of existing natural vegetation, affect the existing natural landscape, or cause any adverse visual impact on the surrounding environment.

- (h) The vehicular access road and parking provision proposed should be appropriate to the scale of the development and comply with relevant standards. Access and parking should not adversely affect existing trees or other natural landscape features. Tree preservation and landscaping proposals should be provided.
- (i) The proposed development should not overstrain the capacity of existing and planned infrastructure such as sewerage, roads and water supply. It should not adversely affect drainage or aggravate flooding in the area.
- (j) The proposed development must comply with the development controls and restrictions of areas designated as water gathering grounds.
- (k) The proposed development should not overstrain the overall provision of G/IC facilities in the general area.
- (l) The proposed development should not be susceptible to adverse environmental effects from pollution sources nearby such as traffic noise, unless adequate mitigating measures are provided, and it should not itself be the source of pollution.
- (m) Any proposed development on a slope or hillside should not adversely affect slope stability.

## Relevant extract of the Town Planning Board Guidelines for <u>Application for Developments within Deep Bay Area</u> (TPB PG-No. 12C)

On 16.5.2014, the Town Planning Board Guidelines for Application for Developments within Deep Bay Area under Section 16 of the Town Planning Ordinance (TPB PG-No. 12C) were promulgated by the Town Planning Board, which set out the following criteria for the Wetland Buffer Area (WBA):

- (a) The intention of the WBA is to protect the ecological integrity of the fish ponds and wetland within the WCA and prevent development that would have a negative off-site disturbance impact on the ecological value of fish ponds. A buffer area of about 500m along the landward boundary of the WCA is thus designated as a WBA. As a substantial amount of the fish ponds within the WBA have already been lost over time through filling and certain areas have been degraded by the presence of open storage use, these degraded areas may be considered as target areas to allow an appropriate level of residential/recreational development so as to provide an incentive to remove the open storage use and/or to restore some of the fish ponds lost.
- (b) Within the WBA, for development or redevelopment which requires planning permission from the Board, an ecological impact assessment would also need to be submitted. Development/redevelopment which may have negative impacts on the ecological value of the WCA would not be supported by the Board, unless the ecological impact assessment can demonstrate that the negative impacts could be mitigated through positive measures. The assessment study should also demonstrate that the development will not cause net increase in pollution load to Deep Bay. Some local and minor uses are however exempted from the requirement of ecological impact assessment. They are listed in Appendix A and include temporary uses.

### **Government Departments' General Comments**

### 1. Land Administration

He has no comment on the application from land adminstration perspective.

### 2. <u>Traffic</u>

- 2.1. Comments of the Commissioner for Transport (C for T):
  - (a) He has no adverse comment on the application from traffic engineering point of view.
  - (b) No vehicles are allowed to queue back to public roads or reverse onto/ from public roads.
- 2.2. Comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD):

He has no comment on the application.

### 3. Environment

Comments of the Director of Environmental Protection (DEP):

- (a) He has no objection to the application. Since septic tank and soakaway pit are provided, he has no comment from sewerage perspective.
- (b) There is no substantiated environmental complaint pertaining to the Site received in the past 3 years.

### 4. Nature Conservation and Animal Management

Comments of the Director of Agriculture, Fisheries and Conservation (DAFC):

- (a) The Site has been developed. He has no comment from nature conservation perspective.
- (b) The Site does not associate with any licence granted by his department, nor has he received any application regarding the Site.
- (c) Under the Public Health (Animals) (Boarding Establishment) Regulations (Cap. 139I), any person who provides food and accommodation for animals in return for a fee paid by the owner must apply for a Boarding Establishment Licence from his department. On the contrary, a shelter does not require a Boarding Establishment Licence to operate if no fee is received by the person operating the shelter.
- (d) He has no comment on the applicant's justifications for the filling of land and excavation of land from animal management point of view.

### 5. Landscaping

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

- (a) The Site is situated in an area of rural coastal plains predominated by temporary structures, open storage yard, vacant land, ponds, scrubland and woodland. The Site is mainly hard-paved, with existing temporary structures and existing trees and vegetation observed at the northeast corner of the Site.
- (b) According to FI dated 13.4.2022 (**Appendix Id**), the location of the proposed car parking spaces in the proposed layout plan are not in conflict with the existing trees and vegetation. As such, further significant landscape impact on existing landscape resources within the Site is not anticipated. She has no comment from landscape planning perspective.

### 6. Drainage

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- (a) He has no objection in principle to the application from drainage point of view.
- (b) Should the Board consider that the application is acceptable from planning point of view, he would suggest that a condition should be stipulated requiring the applicant to submit a revised drainage proposal, to implement and maintain the proposed drainage facilities to the satisfaction of his department.

#### 7. <u>Fire Safety</u>

Comments of the Director of Fire Services (D of FS):

He has no objection in principle to the proposal subject to fire service installations (FSIs) being provided to the satisfaction.

#### 8. <u>Building Matters</u>

Comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD):

As there is no record of approval granted by the Building Authority for the existing structures at the Site, he is not in a position to offer comments on their suitability for the use under application.

#### 9. Environmental Hygiene

Comments of the Director of Food and Environmental Hygiene (DFEH):

(a) Regarding the public comments on rodent infestation/environmental hygiene issue at the Site, his department received 2 rodent complaints in 2021. Anti-rodent measures and technical advice were conveyed to the person in charge of the concerned premises.

# 10. Others

Comments of the Commissioner of Inland Revenue (C of IR):

The applicant, i.e. Kelly Animals Shelter Company Limited, is on the list of charitable institutions and trusts of a public character, which are exempted from tax under section 88 of the Inland Revenue Ordinance (Cap. 112) as of end-February 2022.

### 11. District Officer's Comments

Comments of the District Officer/Yuen Long, Home Affairs Department (DO/YL, HAD):

His office has not received any feedback from locals.

### 12. Other Government Departments' Comments

The following government departments have no comment on the application:

- (a) Chief Engineer/Construction, Water Supplies Department (CE/C, WSD);
- (b) Chief Engineer/Land Works, Civil Engineering and Development Department (CE/LW, CEDD);
- (c) Head of Geotechnical Engineering Office, CEDD (H(GEO), CEDD);
- (d) Project Manager (West), CEDD (PM(W), CEDD); and
- (e) Commissioner of Police (C of P).

### **Recommended Advisory Clauses**

- (a) prior planning permission should have been obtained before commencing the applied use at the application site (the Site);
- (b) to resolve any land issues relating to the development with the concerned owner(s) of the Site;
- (c) to note the comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD) that:
  - (i) the Site comprises an Old Schedule Agricultural Lot (OSAL) and Government Land (GL). The OSAL is held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government;
  - (ii) no permission is given for occupation of the GL included in the Site (about 443m<sup>2</sup> subject to verification). The act of occupation of GL without Government's prior approval is not allowed. It is also noted that an access road is proposed on GL (about 335m<sup>2</sup>) connecting Deep Bay Road and the Site. There is no guarantee that a right-of-way over GL will be granted. In addition, according to the established practice, application of Short Term Tenancy for the purpose of access on GL will not be entertained, even if the planning application is approved by the Town Planning Board.
  - (iii) the lot owner(s) of the lot will need to immediately apply to DLO/YL of LandsD for permitting the structures to be erected or to regularise any irregularities on site, if any. The applicant has to either exclude the GL from the Site or immediately apply for a formal approval prior to the actual occupation of the GL. Besides, given the proposed use is temporary in nature, only application for regularisation or erection of temporary structure(s) will be considered. Application(s) for any of the above will be considered by LandsD acting in the capacity of the landlord or lessor at its sole discretion and there is no guarantee that such application(s) will be approved. If such application(s) is approved, it will be subject to such terms and conditions, including among others the payment of rent or fee, as may be imposed by LandsD;
- (d) to note the comments of the the Commissioner for Transport (C for T) that sufficient manoeuvring space shall be provided within the Site.
- (e) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD) that an access road or run-in/out (in accordance with the latest version of HyD Standard Drawings no. H1113 and H1114, or H5133, H5134 and H5135, whichever set is appropriate to match with the existing adjacent pavement) should be designed and constructed by the applicant to the satisfaction of the Transport Department and HyD. Access road branching off Deep Bay Road leading to the Site should not be maintained by HyD. Adequate drainage measures shall be provided to prevent surface water running from the Site to the nearby public roads and drains;
- (f) to note the comments of the Director of Agriculture, Fisheries and Conservation (DAFC) that under the Public Health (Animals) (Boarding Establishment) Regulations (Cap. 139I), any person who provides food and accommodation for animals in return for a fee

paid by the owner must apply for a Boarding Establishment Licence from the Agriculture, Fisheries and Conservation Department. The establishment and ancillary facilities which is licensed under the Cap 139I Public Health (Animals) (Boarding Establishment) Regulations must always fulfill the criteria listed in the Regulations. The dogs kept by the applicant should also be properly licensed in accordance with the Rabies Ordinance (Cap. 421). The applicant is reminded to observe the Prevention of Cruelty to Animals Ordinance (Cap. 169) at all times.

- (g) to note the comments of the Director of Environmental Protection (DEP) to follow the requirements stipulated in "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites"; to provide adequate supporting infrastructure/facilities for proper collection, treatment and disposal of waste/wastewater generated from the proposed use. The design and construction shall follow the requirements of Environmental Protection Department's Practice Note for Professional Person (ProPECC) PN 5/93 "Drainage Plans subject to Comment by the Environmental Protection Department" including percolation test; to keep the animals inside the enclosed soundproofing structures between 8:00p.m. and 9:00 a.m. on the Site with soundproofing materials with provision of mechanical ventilation and air-conditioning system; to avoid using whistle, public announcement system, portable loudspeaker or any form of audio amplification system on the site; to avoid filling the land with construction waste, and to follow the Recommended Pollution Control Clauses for Construction Contracts (https://www.epd.gov.hk/epd/english/environmentinhk/ eia planning/guide ref/rpc.html) to minimize the environmental impacts during the construction stage; and to meet the statutory requirements under relevant pollution control ordinances:
- (h) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that (i) peripheral surface channels shall be provided along the site boundary to collect the surface runoff accrued on the Site and to intercept the overland flow from the adjacent lands; (ii) the applicant is required to demonstrate with hydraulic calculation that the proposed drainage facilities are adequate to collect, convey and discharge the surface runoff accrued on the application site and the overland flow intercepted from the adjacent lands; (iii) the ground to the south of the Site is significantly higher. Since the overland flow from the adjacent lands shall be probably intercepted, external catchment shall be considered in the calculation; (iv) the pond, to which the applicant proposed to discharge the stormwater from the subject site was not maintained by DSD. The applicant should identify the owner of the existing drainage facilities and obtain consent from the owner prior to commencement of the proposed works. In the case that it is a local village drains, District Officer/Yuen Long should be consulted; (v) further to (iv) above, since there is no record of the said pond, site photos shall be provided to demonstrate its presence and existing condition; (vi) gradients and the sizes of the proposed U-channels should be shown on the drainage plan; (vii) the cover levels and invert levels of the proposed U-channels, catchpits/sand traps should be shown on the drainage plan; (viii) cross sections showing the existing and proposed ground levels of the captioned site with respect to the adjacent areas should be given; (ix) sand trap or provision alike should be provided before the collected runoff is discharged to the public drainage facilities; (x) standard details should be provided to indicate the sectional details of the proposed u-channel and the catchpit/sand trap; (xi) where walls or hoarding are erected are laid along the site boundary, adequate opening should be provided to intercept the existing overland flow passing through the Site; (xii) the development should neither obstruct overland flow nor adversely affect existing natural streams, village drains, ditches and the adjacent areas, etc.; (xiii) the applicant should consult DLO/YL of LandsD and seek consent from the relevant owners for any drainage works

to be carried out outside its lot boundary before commencement of the drainage works.

- (i) to note the comments of the Director of Fire Services (D of FS) that in consideration of the design/nature of the proposal, fire service installations (FSIs) are anticipated to be required. The applicant shall submit relevant layout plans incorporated with the proposed FSIs to the Fire Services Department for approval. The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy. The location of where the proposed FSIs to be installed should be clearly marked on the layout plans. The applicant is reminded that if the proposed structure(s) is required to comply with the Buildings Ordinance (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans;
- (j) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD) that if the existing structures (not being a New Territories Exempted House) are erected on leased land without the approval of the Building Authority (BA), they are unauthorised building works (UBW) under the Buildings Ordinance (BO) and should not be designated for any proposed use under application. For UBW erected on leased land, enforcement action may be taken by the BD to effect their removal in accordance with the prevailing enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO. Before any new building works (including containers/open sheds as temporary buildings, demolition and land filling, etc.) are to be carried out on the Site, prior approval and consent of BA should be obtained, otherwise they are UBW. An Authorised Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO. The Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively. The Site abuts on a specified street (Deep Bay Road) of not less than 4.5m wide. Its permitted development intensity shall be determined under the First Schedule of the B(P)R at the building plan submission stage. Any temporary shelters or converted containers for office, storage, washroom or other uses that are considered as temporary buildings are subject to the control of Part VII of the B(P)R. If the proposed use under application is subject to issue of a licence, the applicant should be reminded that any existing structures on the Site intended to be used for such purposes are required to comply with the building safety and other relevant requirements as may be imposed by the licensing authority. Detailed checking under the BO will be carried out at building plan submission stage; and
- (k) to note the comments of the Director of Food and Environmental Hygiene (DFEH) that proper licence/permit issued by the Food and Environmental Hygiene Department (FEHD) is required if there is any food business/catering service/ activities regulated by DFEH under the Public Health and Municipal Services Ordinance (Cap. 132) and other relevant legislation for the public and the operation of any business should not cause any obstruction. If the proposal involves any commercial/trading activities, there should be no encroachment on the public place and no environmental nuisance should be generated to the surroundings. Its state should not be a nuisance or injurious or dangerous to health and surrounding environment. Any animal carcass/parts shall be properly wrapped or bagged before disposal and in accordance with the relevant legislation. Also, for any waste generated from the activities in the premises, the applicant should handle on their own/at their expenses.

我們是一群愛護動物的義工以及環保人士,我們表示極力反對Kelly Animals Shetler (下稱 "KAS") 臨時動物寄養所之有關申請 (申請編號: A/YL-LFS/423),現作出以下投訴,望當局嚴 正執法。

KAS在現址約3年,一直未有自律處理好垃圾及雜物問題,不論場內場外,長年堆積如山,附近人士及義工多番勸喻不果。場主習慣堆積垃圾於空地約一星期才命人處理,當中包括排泄物和殘羹剩飯,以致長期滋生大量腐蟲和產生惡臭。小巴站附近的垃圾站,亦根本無法容納堆積已久的垃圾量,因此常見垃圾散落於小巴站附近的情況。髒水溢出,腐蟲滋生,臭味濃烈,區內路經此地的人難以逃避惡臭,苦無對策。

垃圾及雜物問題未被正視,繼而逐漸引發日益嚴重的鼠患問題。自2021開始,老鼠在區內已 成困擾,KAS成為溫床老鼠和細菌之地,亦不時有老鼠擴張板圖至附近建設。場內的雜物一 日未除,即使於去信食環署滅鼠,亦未見成效,鼠蟻至今仍然有增無減。不少義工反映惡劣 的衛生問題直接影響場內動物的健康和生活,更是散播病菌,妄顧義工安全之舉。


此外,大量私家車輛停泊佔路,亦造成附近人士一大困擾。空地被雜物佔據,到訪車輛停泊 在唯一出入的車路,或逗留多時卸貨,多次釀成擠塞。以上問題直接影響附近工作或居住人 士以外,更令熱愛大自然的行山人士敬而遠之,十分滋擾。

我們就以上問題曾主動接觸KAS負責人,但多次不獲理會,即使稍有改善亦很快打回原形, 種種証據,可見KAS負責人毫無公德心,謊話連篇,諸多狡辯。不少曾到訪的義工也能作 証,該團體積極收集流浪狗,但根本無心也無力照顧,以致極多動物困至病死餓死。此等行 為說明KAS並沒有履行其宣揚之"尊重生命"之宗旨,反而立下極反面的教材給普羅大眾,誤解 愛護動物的意義。故此,我們懇請委員會再三覆核此規劃申請,不要讓此等動保界毒瘤繼續 為害。



I been to the shelter many times myself and I found it is not providing any welfare for those ani mals in terms of hygiene and safety. If allows to expend of the facility, this permission is helpin g the problem itself to become a lot severe and out of control.

Hygiene. I understand the shelter located in Tuen Mun & Yuen Long West District so pest and mouse is common and inevitable thing. However, I saw bunches of mouse eating in dog food bo wels, havoc around the living places of dogs and bring deadly infectious diseases to those poor a nimals' life. I notice this hygienic problems is not likely to be solved by the kennel keeper as I s ee no actions has been made to preventing the mouse n dogs sharing in the same cages or living spaces.

Safety. In the shelter, those homeless dogs are kept n locked in cages. However those cages mus t've worn out and without a proper maintenance for a long period of time which leaving sharp m etal edges exposed leaving a fatal death trap for dogs. Dogs always move around in their cages which can be easily scratched or in any attempts to escape their cages would lead them trap by t he dead sharp edges in which they cannot either free themselves without severely injured themse lves. Unnecessary potential life dangers are lurking around those homeless dogs each day.

It is brutal for those poor souls staying and living under this terrible managed shelter. If allowed the expansion for this shelter, it will becoming the accomplice to letting more lives will be suffer ed as nothing of aforementioned issues are solved. Hence, I am strongly opposed of on the event of filling and excavation of land to allow temporary animal boarding.
