- Please be advised that the subject site is within the proposed boundary of San Tin / Lok Ma Chau Development Node (STLMC DN). According

to the latest tentative development programme of STLMC DN, the construction work and land resumption will commence after the FC funding approval tentatively by 2024. Thus, the subject site, within the boundary of STLMC DN, will probably be required for timely clearance and construction.
