- (a) the Site comprises an Old Schedule Agricultural Lots (OSAL) and GL. The OSAL is held under Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the government;
- (b) the private land of Lot No. 156 S.B RP in D.D. 105 and GL in the Site are covered by Short Term Waiver (STW) No. 4279 and Short Term Tenancy (STT) No. 2988 respectively for the purposes of "Temporary Open Storage of Recyclable Metal with Ancillary Office";
- (c) it is noted that a staff rest room is proposed in the Site. According to LandsD's prevailing policy, no STT/STW application to permit structure for domestic purpose will be considered. LandsD reserves the right to take enforcement action against such domestic purpose structure in the Site, if any; and
- (d) his advisory comments are at Appendix V.

2. Traffic

- (i) Comments of the Commissioner for Transport (C for T):
 - (a) the Site is connected to the public road network via a section of a local access which is not managed by Transport Department (TD). The land status of the local access road should be clarified with LandsD by the applicant. Moreover, the management and maintenance responsibilities of the local access should be clarified with the relevant lands and maintenance authorities accordingly;
 - (b) as there is no information about the vehicular access at the private lot(s) to the Site, the applicant should seek the relevant land owner(s) on the right of using the vehicular access;
 - (c) the applicant should ensure that the vehicles would not encroach the opposite lane when turning to Castle Peak Road San Tin from the Site via the vehicular access, and vice versa; and
 - (d) should the application be approved, a condition should be incorporated that no vehicle is allowed to queue back to or reverse onto/from public road at any time during the planning approval period.
- (ii) Comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD):
 - (a) the access arrangement of the Site from Castle Peak Road San Tin should be approved by Transport Department;

- (b) HyD shall not be responsible for the maintenance of any access connecting the Site and Castle Peak Road San Tin: and
- (c) adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to the nearby public roads or exclusive road drains.

3. Landscape

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

since the Site is not located within a landscape sensitive zoning and there are existing trees as buffer planting around the Site, no significant landscape impact arising from the proposed development is anticipated. Should the Board decide to approve the application, it is considered not necessary to impose a landscape condition in the planning permission.

4. Fire Safety

Comments of the Director of Fire Services (D of FS):

- (a) he has no objection in principle to the application subject to fire service installations (FSIs) being provided to his satisfaction;
- (b) in consideration of the design/nature of the proposal, FSIs are anticipated to be required. The applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. The layout plan should be drawn to scale and depicted with dimensions and nature of occupancy; and the location of where the proposed FSIs to be installed should be clearly marked on the layout plans. The applicant should also adhere to the good practice guidelines for open storage;
- (c) having considered the nature of the open storage, should the application be approved by the Board, an approval condition should be stipulated requiring the applicant to provide fire extinguisher(s) within 6 weeks from the date of the planning approval to the satisfaction of D of FS. To address this condition, the applicant is advised to submit a valid fire certificate (FS 251) for approval by his department; and
- (d) the applicant is reminded that if the proposed structure(s) is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans.

5. Drainage

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- (a) he has no objection in principle to the application from drainage operation and maintenance point of view;
- (b) it is noted that the applicant implemented the drainage facilities on the Site under the previous application No. A/YL-ST/546. The use and the site area under the current application are the same as the previous application. The applicant shall provide

DSD a set of record photographs showing the completed drainage works (including the internal condition of the drains) with corresponding photograph locations marked clearly on the approved drainage plan for reference. DSD will inspect the completed drainage works jointly with the applicant with reference to the comprehensive set of photographs; and

(c) his advisory comments are at Appendix V.

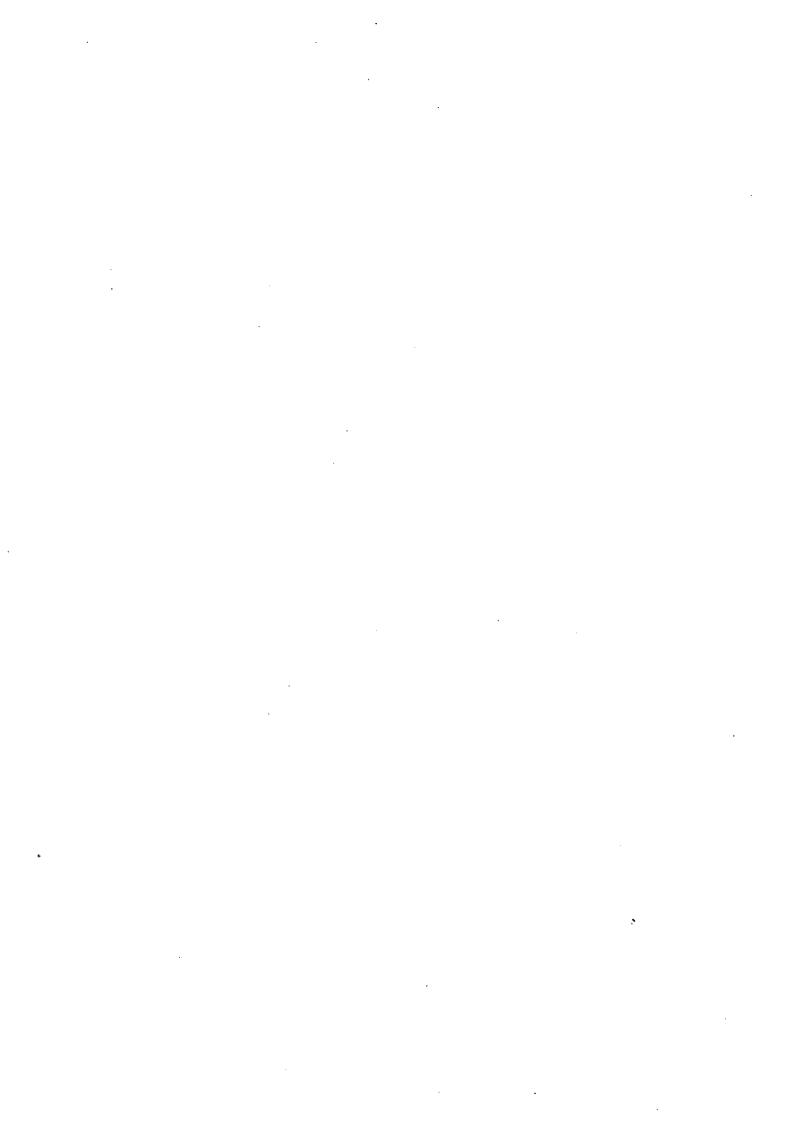

 - (iii) according to LandsD's prevailing policy, no STT/STW application to permit structure for domestic purpose will be considered. LandsD reserves the right to take enforcement action against such domestic purpose structure in the Site, if any; and
 - (iv) the STT/STW holder(s) will need to apply to LandsD for modification of the STT/STW conditions where appropriate. Besides, given the applied use is temporary in nature, only application for regularisation or erection of temporary structure(s) will be considered. Application(s) for any of the above will be considered by LandsD acting in the capacity of the landlord or lessor at its sole discretion and there is no guarantee that such application(s) will be approved. If such application(s) is approved, it will be subject to such terms and conditions, including among others the payment of rent or fee, as may be imposed by LandsD;
- (c) to note the comments of the Commissioner for Transport (C for T) that:
 - (i) the Site is connected to the public road network via a section of a local access which is not managed by Transport Department (TD). The land status of the local access should be clarified with LandsD by the applicant. Moreover, the management and maintenance responsibilities of the local access should be clarified with the relevant lands and maintenance authorities accordingly;
 - (ii) the applicant should seek the relevant land owner(s) on the right of using the vehicular access; and
 - (iii) the applicant should ensure that the vehicles would not encroach the opposite lane when turning to Castle Peak Road San Tin from the Site via the vehicular access, and vice versa;

- (d) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department (CHE/NTW, HyD) that HyD shall not be responsible for the maintenance of any access connecting the Site and Castle Peak Road San Tin; and adequate drainage measures should be provided at the site access to prevent surface water flowing from the Site to the nearby public roads or exclusive road drains;
- (e) to follow the relevant mitigation measures and requirements in the latest "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites" to minimise potential environmental impacts on the surrounding areas;
- (f) to note the comments of the Director of Fire Services (D of FS) that:
 - (i) FSIs are anticipated to be required in consideration of the design/nature of the proposal. The applicant is advised to submit relevant layout plans incorporated with the proposed FSIs to his department for approval. The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy, the location of the proposed FSI should be clearly marked on the layout plans, and good practice guidelines for open storage should be adhered to (Attachment);
 - (ii) to address the approval condition on submission of fire extinguisher(s), the applicant is advised to submit a valid fire certificate (FS251) to his Department for approval; and
 - (iii) the applicant is reminded that if the structure(s) on site is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans;
- (g) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD) that:
 - (i) the applicant shall provide DSD a set of record photographs showing the completed drainage works (including the internal condition of the drains) with corresponding photograph locations marked clearly on the approved drainage plan for reference. DSD will inspect the completed drainage works jointly with the applicant with reference to the comprehensive set of photographs;
 - (ii) the applicant shall ascertain that all existing flow paths would be properly intercepted and maintained without increasing the flooding risk of the adjacent areas;
 - (iii) no public sewerage maintained by CE/MN, DSD is currently available for connection. For sewage disposal and treatment, agreement from the Director of Environmental Protection shall be obtained;

- (iv) the applicant is reminded that the proposed drainage works as well as the site boundary should not cause encroachment upon areas outside his jurisdiction;
- (v) the applicant should consult DLO/YL, LandsD regarding all the drainage works outside the lot boundary in order to ensure the unobstructed discharge from the Site in future; and
- (vi) all the proposed drainage facilities should be constructed and maintained by the applicant at his own cost. The applicant should ensure and keep all drainage facilities on site under proper maintenance during occupancy of the Site; and
- (h) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD) that:
 - (i) before any new building works (including containers/open sheds as temporary buildings, demolition and land filling, etc.) are to be carried out on the Site, prior approval and consent of the Building Authority (BA) should be obtained, otherwise they are unauthorised building works (UBW) under BO.  - (vi) detailed checking under BO will be carried out at the building plans submission stage.
