Amendment 'Columbarium' ("OU(Columbarium)")

1. Background

- 1.1 On 31.7.2020, the applicant sought planning permission to rezone the application site (the Site) (**Plan Z-1**) from "V" and "REC" to "OU(Columbarium)" to facilitate the development of a columbarium with 864 niches under the name of Liberty Fook Kui (自由福居).
- 1.2 On 23.10.2020 and 5.2.2021, the Rural and New Town Planning Committee (the Committee) of the Town Planning Board (the Board) agreed to defer making a decision on the application for two months, as requested by the applicant, to allow time for the applicant to prepare further information (FI) to address departmental comments. The applicant submitted FI on 24.3.2021 and the application is scheduled for consideration by the Committee on 11.6.2021.

2. Request for Deferment

On 27.5.2021, the applicant's representative wrote to the Secretary of the Board and requested the Board to defer making a decision on the application for another two months in order to allow more time to prepare FI to address further comments of Transport Department (TD) and Drainage Services Department (DSD) (**Appendix I**).

3. Planning Department's Views

- 3.1 The application has been deferred twice for a total of four months at the request of the applicant to allow more time to address departmental comments. Since the last deferment on 5.2.2021, the applicant's representative submitted FI on 24.3.2021 including a revised Traffic Impact Assessment (TIA) and responses-to-comments for the columbarium to address the departmental comments. Nevertheless, the applicant needs more time to prepare FI to address the further comments from TD and DSD.
- 3.2 The Planning Department <u>has no objection</u> to the request for deferment as the justification for deferment meets the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that the applicant needs more time to prepare FI to address the departmental comments, the deferment period is not indefinite, and the deferment would not affect the interests of other relevant parties.
- 3.3 Should the Committee agree to defer making a decision on the application, the application will be submitted to the Committee for consideration within three months upon receipt of FI from the applicant. If the FI submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed further two months for preparation of FI submission. Since it is the third deferment of the application, the applicant should be advised that the Committee has allowed a total of six months for preparation of FI submission, this is the **last deferment** and no further deferment would be granted.

4. <u>Decision Sought</u>

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Committee for consideration at the next meeting.
