1. Background

- 1.1 On 17.6.2021, the applicant's representative submitted the application to rezone the application site from "GB" to "R(A)1" on the Lau Fau Shan and Tsim Bei Tsui OZP and from "O(1)" to "R(A)2" and an area shown as 'Road' on the Tin Shui Wai OZP to facilitate a proposed residential development (**Plan Z-1**).
- 1.2 On 23.12.2022, the Rural and New Town Planning Committee (the Committee) of the Town Planning Board (the Board) agreed to defer making a decision on the application for two months, as requested by the applicant's representative, to allow time to prepare further information (FI) to address departmental comments. On 3.2.2023, the applicant's representative submitted FI to substantiate the application. The application is scheduled for consideration by the Committee at this meeting.

2. Request for Deferment

On 8.5.2023, the applicant's representative wrote to the Secretary of the Board again and requested the Board to defer making a decision on the application for two months in order to allow more time to prepare FI to address departmental comments (**Appendix I**).

3. <u>Planning Department's Views</u>

- 3.1 The Planning Department has <u>no objection</u> to the request for the second deferment as the justifications for deferment meet the criteria as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33A) in that the deferment would allow the applicant to prepare FI to address outstanding issues.
- 3.2 Should the Committee agree to defer a decision on the application, the application will be submitted to the Committee for consideration within three months upon receipt of FI from the applicant. If the FI submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed a total of four months for preparation of submission of FI, and no further deferment would be granted unless under very special circumstances.

4. Decision Sought

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted for the Committee's consideration at the next meeting.
